


Two Degree Alignment

Their transition pathway approach is adapted from methodologies highlighted by the Science Based Targets Initiative (which represents a collaboration by the non-governmental organizations CDP, UNGC, WRI, and WWF). Values below zero are aligned, while those above zero are misaligned.
