## What is the product?

Type: This product is a Société d'Investissement à Capital Variable (SICAV).

Term: The fund has been established for an indefinite period of time. The PRIIP Manufacturer reserves the right to liquidate the fund, subject to approval by the Board of Directors.

Objectives: The fund seeks total return, by investing, under normal circumstances, at least two-thirds of its total assets in credit debt securities rated below investment grade (i.e., BB+ or lower by Standard & Poor's or Ba1 or lower by Moody's or an equivalent quality rating from another internationally recognised credit ratings organisation or are deemed by the Sub-Investment Managers to be of comparable quality) at the time of purchase, which may include Green Bonds and perpetual bonds, issued by corporate issuers domiciled anywhere in the world. The fund promotes environmental and/or social characteristics but does not have a sustainable investment objective. The fund will invest no more than 10% of its net assets in securities issued or guaranteed by a single government issuer. The fund may invest up to 10% of its total assets in equity securities is including those acquired as a result of an issuer's compulsory conversion of its debt instruments into equities. The fund may invest up to 5% of its total assets in contingent convertible bonds. The fund may invest on more than 10% of its net assets in unrated, distressed or defaulted debt securities rated C by Moody's or D by Standard & Poor's. The fund will target to decarbonise by 2050. This is intended to be achieved by setting a decarbonisation profile for the fund at inception that has a carbon intensity that is least 30% lower than the ICE BofA Developed Markets High Yield Constrained Index (USD Hedged). The assets within the fund are unenally with a trajectory to decarbonise by 2050. Through the use of a negative screening process, the fund seeks to exclude certain securities in accordance with its exclusion polic.
