What is the product?

Type: This product is a Société d'Investissement à Capital Variable (SICAV).

Term: The fund has been established for an indefinite period of time. The PRIIP Manufacturer reserves the right to liquidate the fund, subject to approval by the Board of Directors.

Objectives: The fund seeks to maximise investment income while preserving capital, by investing at least two-thirds of its total assets in Euro-denominated credit debt securities, rated investment grade at the time of purchase, issued by sovereign or corporate issuers. Investment grade means bearing a credit rating of BBB- and/or Baa3 or equivalent and above from any one of the following credit rating agencies: Standard & Poor's, Moody's or Fitch, where an investment is not rated by either Standard & Poor's, Moody's or Fitch and where the Sub-Investment Manager consults with such other external sources that are available and uses its professional judgement, supported by at least one external opinion that such investment is of investment grade rating. While the fund may purchase securities of any maturity or duration, under normal circumstances, its average weighted duration is expected to be up to 3.5 years or less. The fund promotes environmental and/or social characteristics but does not have a sustainable investment objective. The fund may invest up to one-third of its total assets in currency-hedged non-Euro-denominated debt securities and foreign agencies; up to 10% of its total assets in investment grade asset-backed securities including mortgage-backed securities and commercial mortgage-backed securities; up to 10% of its total assets in debt securities rated below investment grade at the time of purchase; and up to 7.5% of its total assets in contingent convertible bonds. The fund will not invest in assets rated below B-/B3. In the case of a downgrade on an existing investment below B-/B3, the downgraded assets must be sold by the fund in an orderly and timely manner in accordance with the general applicable principles. The fund will utilise the Allspring ESGiQ (ESG Information Quotient), a proprietary rating system created to assess ESG risk and materiality. The fund will invest at least two-thirds of its total assets in issuers that have an overall ESGiQ score of 3+ or higher and will exclude issuers that have an ESGiQ score that is rated 2 or lower or not rated at all. Sovereign issuers, cash, derivatives and investments in underlying funds will not be required to have an ESGiQ score. The fund targets to have a carbon intensity that is lower than the Bloomberg Euro Aggregate Corporate Bonds 1-5 Yr. Index (EUR Unhedged). Through the use of a negative screening process, the fund seeks to exclude certain securities in accordance with its exclusion policy. Shareholders may also request a copy from the fund or the Management Company. The fund may also use futures, forward contracts, options, or swap agreements, as well as other derivatives, for hedging, efficient portfolio management or investment purposes. The fund's fundamental credit research combined with active top-down allocation decisions within a controlled risk framework seek to generate superior investment returns. The fund is actively managed but uses the Bloomberg Euro Aggregate Corporate Bonds 1-5 Yr. Index (EUR Unhedged) for performance comparison. The investments of the fund may deviate significantly from the components of and their respective weightings in the benchmark. You may redeem your investment upon demand on each business day when banks in Luxembourg are open for normal business and the New York Stock Exchange is open for trading (a "Business Day"). This share class intends to distribute dividends net of expenses monthly.

Intended Investor:

This product is intended for investors of all knowledge and/or experience levels seeking returns based on the credit risk of European investment grade corporate bonds (including financial institutions), who have an investment horizon of 3 years or longer and who have a risk tolerance compatible with the product's SRI rating.
